Re: Motion to Overturn the Executive Director's decision to grant the City of Farmers Branch's application to modify Municipal Solid Waste (MSW) Permit No. 1312A; TCEQ Docket No. 2014-1487-MSW.

The above-referenced Motion to Overturn (Motion) was filed by the City of Carrollton (Carrollton) on October 16, 2014, and requests that the Commission overturn the Executive Director's decision to grant the City of Farmers Branch's (Farmers Branch) application to modify MSW Permit No. 1312A. Title 30 of the Texas Administrative Code Chapter 50 authorizes the Office of General Counsel (OGC) to extend the period of time for taking action on a Motion to Overturn up to 90 days after the date a party is notified of the decision or order. In this case, notice was mailed on September 23, 2014. This letter shall serve as the order extending the deadline for the Commission to act on this Motion until **Friday, December 12, 2014**.

This letter is also to notify the Executive Director, the Office of Public Interest Counsel, and Farmers Branch that they are strongly encouraged to file response briefs to the Motion with the Commission's Office of Chief Clerk (OCC) on or before **5:00 P.M. on Thursday, November 13, 2014**. Carrollton may file a reply brief on or before **5:00 P.M. on Tuesday, November 25, 2014**. To be considered timely, an original and seven (7) copies of any response or reply brief must be received in the OCC on or before the applicable 5:00 P.M. deadline. All briefs must be filed with the Chief Clerk, should also be addressed to the attention of the Agenda Docket Clerk, and should be marked with the TCEQ Docket number provided above. Responses and replies may be filed with the Chief Clerk electronically at <http://www.tceq.texas.gov/goto/eFilings> *or* by filing an original and seven (7) copies with the Chief Clerk of the TCEQ. All response and reply briefs should also be mailed to all other persons on the attached mailing list on the same day they are mailed or filed in the OCC.

All written filings on this matter will be considered, and OGC will inform the parties by letter if the Motion will be set for consideration at a Commission public meeting.
